**1. FEE SCHEDULE "E" - AMENDMENT**

1. Moved by Councillor Cooper that Council amend Schedule "E" of Bylaw 32/96, the Fee Schedule Bylaw, to increase the application fees related to Municipal Development Plan, Area Structure Plan, Area Redevelopment Plan, and Land Use Bylaw proposals and amendments (Section 3 of Schedule "E") so that the new fees are as follows:

Textural Amendment to existing MDP, ASP, ARP or LUB	\$4,000 plus \$100/ha of land involved to a maximum of \$25,000*
Map/Re-districting Amendment to existing MDP, ASP, ARP or LUB or addition Of a use to an existing LUB District	\$3,000
New ASP or ARP	\$4,000 plus \$200/ha of affected area to a maximum of \$25,000

- \* Where an MDP or LUB amendment is required in the context of a new ASP or ARP proposal, the \$100/ha land area fee may be waived, at Council's sole discretion, in light of the \$200/ha fee required for the new ASP or ARP.
