11.1.0 ESTABLISHMENT OF DISTRICTS

11.1.1 For the purposes of this By-law, the land within the boundaries of the Municipality shall be divided into one or more of the Districts as established in Section 11.2.0.

11.1.2 Throughout this By-law and amendments thereto a District may be referred to either by its full name or its abbreviation as set out in Section 11.2.0.
